PRESIDENT'S REPORT

Daniel Aghion KC

Leading the community by example

The JCCV executive operates on a three year term. In the 2021 report, I said that the current executive had the following goals:

First, to restore the credibility of the JCCV
Second, a JCCV which leads the community by example
Third, a sound financial footing
Fourth, the identification of matters which meet the common aspirations of the community as a whole. It is in those matters where unity can be found.

Achieving our current goals and working towards our future goals.

In 2021, we met and exceeded our first goal. The 2022 calendar year has been directed towards meeting our second goal, of leading the Victorian community by example. I believe that we have succeeded in this goal as well. Our success can best be seen through the extensive work described in the report of our CEO, Judy Fetter. I would like to thank all JCCV executive members for their contributions.

The JCCV staffing team has also evolved with Josh Goodman being employed as a Project Officer in August, and Naomi Levin being appointed Chief Operating Officer in May. I thanks the JCCV staff – Judy, Naomi, Hilary and Josh, for their tireless efforts and extend my appreciation to them for their hard work.

These staffing additions have resulted in a

significant uptick in JCCV operations, including increased Jewish Immersion Programs, improved communications with the Jewish community, and freeing up Judy Fetter, our CEO, to focus on strategic, rather than operational matters.

We continue to attract new affiliate organisations, while retaining those who have been associated with us for decades. I am regularly contacted by media organisations to contribute to public debates relevant to our community. We continue to lead, and also to respond on the key issues affecting Jewish Victorians, including antisemitism.

We continue our work including continuing to link our community to government at all levels, diverse multicultural communities and other key stakeholders.

Our third goal continues to be a work-in-progress: to create a sound financial footing for the JCCV. I am pleased to say we have secured three patrons, who have each made a sustained commitment. My objective is to add to the list of patrons in the very near future.

Key successes

Some of the JCCV's key successes in 2021-22 include:

 Government advocacy – The JCCV has worked hand-in-hand with the Victorian Government on a range of issues important to our community, including COVID-19 public health response, antisemitism training for government school teachers, and implementing laws to combat antisemitism.

- Tikkun Olam The JCCV is keen to contribute to a creating a better world, this includes completing the acquittal of the \$3.1 million Victorian Bushfire Relief Appeal; supporting LGBTIQ+ community members; and actively working towards Reconciliation with Australia's First Nations.
- Holocaust remembrance Hosting the largest community Yom Hashoah commemoration in April.
- Bringing community together working with JCCV affiliates on a range of projects and programs, including
- co-hosting events and forums throughout the year.
- Education Expanding the JCCV's Jewish Immersion Program to three local councils: Glen Eira, Port Phillip and Stonnington.

In the 2022-2023 year we must consolidate these gains and continue to communicate our successes. Most importantly, we must tackle our third goal, to put the JCCV on a sound financial footing. This requires us to find financial support from within our community to sustain our operations into the future.

CHIEF EXECUTIVE OFFICER'S REPORT Judy Fetter

The past year of COVID-19 related challenges has given the JCCV an opportunity to redefine our role. We have collaborated, listened and delivered with renewed focus and purpose. As a result, the JCCV has made significant steps forward to proudly support our collective Jewish way of life in Victoria.

Advocating for our community and ensuring open dialogue with our affiliates, the Victorian Government, local councils, Victoria Police and Victorian Multicultural Commission ensured our central roof body was relevant, respected and trusted. Regular meetings with senior Department of Health officials on helping deliver COVID-19 related messaging during difficult periods and to support and guide the Jewish community directly and via our affiliate organisations was significant.

Leading the consultation process with the Attorney-General Victorian and the Department of Justice and Community Safety on the banning of the public display of the Nazi swastika in Victoria; working with the Department of Education and Training to educate state school staff on antisemitism, manifestations and reporting mechanisms; and expanding the role and reach of Jewish Immersion Programs (JIP) to local council staff and health service providers have been major achievements for the JCCV this year.

Our focus has also been on raising awareness and enabling action on key issues for our community. These include affordable and sustainable models for Jewish education for next generations raised by Jewish Schools Project; safeguarding the vulnerable through partnering with MAOZ;

safety and security issues with CSG in a period of growing antisemitism globally; leading JCCV First Nations Reconciliation Programs; and diligently managing distributions for the Victorian Jewish Bushfire Relief Appeal to ensure communal funds were allocated effectively and in a timely manner.

The Yom Hashoah community commemoration remains a central responsibility of the JCCV. Due to the pandemic, we had to reimagine its style and delivery, while retaining the personal connection with survivors and their families and embracing youth involvement. Our solemn messages reached over 2,000 people in 2022, more than ever before.

I am proud to work with such a devoted yet small team of professionals to bring these achievements to life. My thanks to Naomi Hilary McMahon and Levin. Joshua Goodman who instrumental are maintaining relationships, creating and delivering these services. Daniel Aghion KC and the JCCV Executive for their insight, guidance and strategic vision for the JCCV and our valued donors for their generosity, trust and loyalty. Together, we have adapted to changing times and delivered across our local and state areas with pride.

ACHIEVEMENTS

ADVOCACY

Partnered with the Victorian Department of Education to deliver antisemitism training to teachers at Brighton Secondary College, with a plan to expanding this training to all Victorian schools in 2023.

At the request of the council CEO, educated City of Glen Eira councillors and assisted City of Glen Eira staff ahead of a Council motion to adopt the International Holocaust Remembrance Alliance Working Definition of Antisemitism.

Worked with the Victorian Department of Health to lead the Jewish community response to COVID-19, including the vaccination campaign



EDUCATION

Partnered with the Jewish Schools Project to host community forums to discuss how to get more children learning in Jewish schools.

COMMUNITY

Participated in the Pride March with Jews of Pride and met with the leaders at the **Victorian Pride Centre**.

Partnered with B'nai B'rith Victoria and The King David School to host Walking Together with First Nations peoples at Pillars of Light in Federation Square, where Indigenous leaders and Jewish leaders lit Chanukah candles together.

Hosted the largest ever Yom Hashoah community commemoration.

Finalised allocations to bushfire affected communities from the \$3 million raised by the Jewish Bushfire Relief Appeal.



Co-hosted two Bystander Training sessions for local council staff and other public service staff together with Courage to Care.

- **Educate.** Teach the broader community about the characteristics, needs and diversity of our community via the JCCV's Jewish Immersion Program and antisemitism training for Victorian teachers.
- Remember. Encourage broad participation in Yom Hashoah commemorations to ensure the memory of the Holocaust never fades.
- **Collaborate.** Bring Victorian Jewish organisations and community leaders together on shared issues to maximise impact, while streamlining resources.







TREASURER'S REPORT Hannah Greenberg

JCCV FINANCIAL REPORT YEAR ENDING 30 JUNE 2022

The year ending June 2022 has been very exciting for the JCCV. Instead of having only two entities – the JCCV and the Cultural Fund, we have now grown to three entities with the addition of Maoz Inc.

JCCV has entered into a partnership with Maoz Inc which is a Harm Prevention Fund that has its own DGR, allowing all donations to be tax deductible. This partnership allows JCCV to offer tax deductibility for two types of donations, that is cultural activities and now harm prevention.

JCCV Inc

The accompanying profit and loss summary shows the JCCV Inc had a total income in the year 2022 of \$576,000. Income from affiliation fees remains strong, in excess of \$90,000. This reflects unwavering support from our affiliates and increased grant income, especially for antisemitism training, and there is strong growth for the year 2022/23.

In 2022 the JCCV decided to discontinue the publication of the JCCV diary. We know this has disappointed some members of the community but from an economic and financial analysis it was considered untenable, with the costs of publication versus the income resulting in a large loss. The JCCV Executive agreed this was the financially responsible decision.

Looking at the expense side of JCCV Inc, the total was in the vicinity of \$489,000. The main component of expenses is wages at

\$287,025 or 56%. A restructure of staffing was required owing to increased demands on the JCCV. In May 2022 the new role of Chief Operating Officer was created and changes from the Business Manger role to Business Administrator role enabled this structure to be sustainable. This increase in salaries planned in 2022/2023 will impact next year's expenses but enable the Chief Operating Officer to concentrate on strategy and fundraising to improve the longer-term viability of the JCCV.

The area of fundraising and donations require a focussed plan to combat the gap in the budget from reduced appeal income in 2021/2022.

In the year ending 2022, the JCCV made a commitment to support the payment plan to pay down the ECAJ debt. This will commence in July of the 2022/23 year, increasing our repayment from \$5,000 per month to \$10,000. We plan to discharge this debt in the next 12 months.

Cultural Fund

The profit and loss of the Cultural Fund shows an income \$87,000. This is down on previous year largely due to a \$50,000 bequest being banked in the JCCV and not the Cultural Fund. Also Appeal income was \$58,800 compared to \$70,200 in the prior year.

The Cultural Fund shows an income line \$7,500 from a new partnership with Walk Together. Walk Together is new project concentrating on relationships with our Indigenous people.



On behalf of the ECAJ councillors, observers, advisers and staff, I wish to extend my congratulations to you and all your colleagues and staff at the Jewish Community Council of Victoria (JCCV) for another successful year of dedicated service to the Victorian Jewish community.

The JCCV continues to support and strengthen the Jewish community in Victoria, bringing members together in numerous events and initiatives, such as the JCCV Planum, deepening ties with its affiliate organisations and establishing valuable relations with various faith and multicultural groups.

During this past year, JCCV under your leadership, and with the support of the Executive Director and staff, have recorded important achievements in combating rising antisemitism and racism. The JCCV played a significant role assisting the Victorian Government in drafting legislation criminalising the display of the Nazi Swastika. In addition, the JCCV provided valuable inputs to the Victorian Parliament Legal and Social Committee's report into extremism in Victoria, which included recommendations for better collection of hate incidents and rejection of extremist rhetoric in the media and the public debate.

In the field of education, the JCCV worked with Victoria's Department of Education and Training to help school staff identify and respond to antisemitism in Victorian schools. Together with ECAJ and other Jewish community organisations, the JCCV provided support to Jewish students and condemned and worked to overturn the antisemitic motion passed by the Melbourne University Student Union.

In this context, your work with the Victorian Government and the Glen Eira City Council leading to their adoption of the IHRA Working Definition of Antisemitism was of particular importance.

I also wish to commend the JCCV on the numerous initiatives and significant work in building relations and developing close connections with faith and multicultural communities. These include the Multicultural Women's Reference Group, bringing together women from diverse backgrounds working to support First Nations people via the Uluru Statement from the Heart, and also the bystander intervention training session, facilitated by Courage to Care Victoria and co-hosted by the JCCV, the Australian Intercultural Society and the Immigration Museum. These are critical steps in paving the future for a more inclusive and tolerant society.

I take this opportunity to thank you for your contributions to the work of the ECAJ as a Councillor and as ECAJ Honorary Secretary and wish you continuing success in your future endeavours.
